2. Lessee affirms that the item(s) described above are his personal property, or property held in his keeping by a duly executed power of attorney; that he is the individual identified as the lessee and that he is in fact entitled to use the Fort Sill Vehicle Resale/Recreational Vehicle Storage Facility.

3. Lessee acknowledges that he and the Lessor jointly have completed the checklist attached to this contract and that it represents a clear and accurate description of the above described item's condition at the time and date signed. Upon each and every removal and return of a vehicle from the RV storage or vehicle resale area it is the Lessee's responsibility to insure another checklist is jointly completed or the current checklist is verified as accurate. Failure to do so by the Lessee may forfeit his/her right to make a claim for damages incurred at the facility and will remove any presumption that the Lessor caused the damage.

4. Lessee agrees that only the property above will be stored in the Vehicle Resale/Recreational Vehicle Storage Facility and that the following individuals with appropriate identification are authorized to remove these items from, or return these items to the facility.

5 The Lessee expressly acknowledges personal liability to pay on demand:

"Total cost to repair collision or upset damages resulting from operating, towing, moving, or attempting to move described items within the confines of the Vehicle Resale/Recreational Vehicle Storage Facility."

6. Lessee is strongly urged to maintain insurance and is cautioned that claims for loss payable by the Government are restricted by AR 27-20, and are generally limited to \$1,000.00.

7. Lessee acknowledges that no maintenance activities are to be performed within the Vehicle Resale/ Vehicle Storage Facility with the sole exception of tire replacement.

8. The Lessee in signing this contract expressly acknowledges reading and agreeing to the following statement:

"Obligations and responsibilities of the parties are governed by Federal law. The Lessor is responsible for only ordinary care to the property stored in the facility. Any failure by the Lessee to meet the requirements of this contract or the Standing Operating Procedures, Subject: Recreation Vehicle Storage and Vehicle Resale Facilities will be considered per se negligence and can result in any claim against CRD, the U.S. Army or the U.S. Government being denied."

9. This contract contains the sole agreement between parties hereto. Lessee warrants that he has read this agreement and same is entered into in sole reliance upon the things and matters set forth herein and contains the only representations made by Lessor concerning rental of Vehicle Resale/ Recreational Vehicle Storage Facility space and/or the provisions and terms of this agreement. Lessee acknowledges having read the Standing Operating Procedures, Subject: Recreation Vehicle Storage and Vehicle Resale Facilities, and understands the policies and procedures.
