NOTICE OF CONSTITUTIONAL AND LEGAL RIGHTS

1. YOU HAVE THE RIGHT TO REMAIN SILENT.
2. ANYTHING YOU SAY CAN BE USED AGAINST YOU IN A COURT OF LAW.
3. YOU HAVE THE RIGHT TO TALK TO A LAWYER AND HAVE A LAWYER PRESENT WHILE YOU ARE BEING QUESTIONED.
4. IF YOU CANNOT AFFORD TO HIRE A LAWYER, ARRANGEMENTS WILL BE MADE TO OBTAIN YOU A LAWYER IN ACCORDANCE WITH THE LAW.
5. IF YOU DECIDE TO ANSWER QUESTIONS, YOU HAVE THE RIGHT TO STOP ANSWERING AT ANY TIME.
6. YOU HAVE THE RIGHT TO CONFER WITH YOUR PARENT IN PRIVATE AT ANY TIME.
