2. Effective immediately, the Security and Intelligence Division, DPTMS, Division Chief is appointed as Fort Sill's Command Security Manager for Information, Personnel, Industrial Security and Security Education Training Awareness. He/she will manage Fort Sill's Security Programs and execute the requirements of the above references governing classified and sensitive information, personnel security investigations, classified contracts and security education training awareness for TRADOC, IMCOM, FORSCOM and tenant organizations.

#### 3. Provide managerial program oversight:

a. Advise on matters related to safeguarding national security information, ensure security violations are reported and implement a security education training and awareness program.

b. In coordination with the Network Enterprise Center, serve as Fort Sill's Secret Internet Protocol Router Network and the Protected Distribution System and classified video-teleconference (VTC) approval authority.

c. Oversee and assist with the emergency destruction plan for classified and/or sensitive information.

d. In accordance with (IAW) ref. e. above, ensure the proper application of personnel security standards and criteria for individuals eligible for access to classified information are used.


e. Provide contractor oversight IAW reference b and d for contractors performing classified contractual activities on the installation.
