SUBJECT: Strategic Deployment School, Course Schedule, FY 15

1. Schedule of subject courses, presented by the Unit Movements Office (UMO), Directorate of Logistics (DOL):

a. **Air Deployment Planning Course (ADPC)**: A 64-hour course presented by personnel from 819 GSS/DOT McGuire AFB, NJ covering equipment preparation, palletization, and airload planning (ICODES). Successful students will receive certification as Airload Planners and credit for 64 hours of training.

b. **Unit Movement Officer Deployment Planning Course (UMODPC)**: An 80-hour course presented by personnel from the Strategic Deployment School. Class instruction covers duties and responsibilities of a Unit Movements Officer, unit equipment preparation and documentation for all modes of transportation, and the use of transportation automated systems. Upon successful completion, students will receive certification and credit for 80 hours of this training.

c. **Transportation of Hazardous Materials Certification Course -AMMO-62 (HMC)**: An 80-hour course presented by the U.S. Army Defense Ammunition Center (DAC) – McAlester Oklahoma, covering procedures for proper packaging and certification of hazardous materials for shipment by all modes of transportation. Successful students will receive certification as Certifying Officials for the Transportation of Hazardous Materials by all modes and credit for 80 hours of training

SUBJECT: Strategic Deployment School, Course Schedule, FY 15

1. **Hands on Training** – FORSCOM/ARNG Regulation 55-1 - Each unit will have an appropriate number of personnel trained in vehicle preparation and aircraft and rail loading and unloading techniques.

a. **Rail Load Training** - Training will cover procedures for correct tie down of military equipment on rail cars ensuring safe rail transport.

b. **Air Load Training** – Training will cover procedures for palletizing cargo on the 463L Pallet Cargo System, center of balance calculations for equipment.

(1) Prerequisites: (UMO) - SSG or above (primary), SGT (alternate), **SECRET** security clearance, 1 year retainability in present unit, and appointed on orders as Unit Movements Officer/Non-Commissioned Officer with a copy of orders in his/her possession.

(2) All classes are subject to be cancelled if there are not at least 10 personnel present to attend the scheduled class.

(3) Maximum number of students per class is 25.

2. Class hours for ADPC, UMODPC, and HMC classes are 0830-1700 Monday through Friday. Hands on Training courses are 09:30-15:00. All classes are held in Building 2276 Hirsch Road. If any changes or cancellations become necessary, BDE schools representative will be notified telephonically.

3. Request Brigade School NCOs provide a list of personnel attending the courses at least 45 days in advance of the class start date to the Unit Movements Office (Ms. Cornelious) and are present at the beginning of each class to determine appropriate attendance and “no shows.” All classes are subject to be cancelled if there are not at least 10 personnel present to attend the scheduled class.
