2. All NCOES Endorsement Packets must be submitted to G3 Training Management by 1400 hrs on the suspense date(s) for that class. Priority 1 -3 will be entered NLT the suspense date. This is the date that Soldiers will be entered into ATRRS based upon Order of Merits List (OML) guidance. Endorsements received after the suspense date will be entered into ATRRS in the order in which they are received to fill remaining seats.
3. Some organizations off post will have allocations for seats in WLC; this is done to ensure all Soldiers have the opportunity to advance up through the ranks.
